Frequently Asked Questions

What is a Sliding Fee Scale?

A Sliding Fee Scale (SFS) bases the amount you are charged for the prescription medications you receive on the size and income of your household. Please see the front of this flier for SFS categories.

What items does the SFS discount cover?

For eligible patients, the SFS discount applies to all prescription medications.

What items are not covered by the SFS discount?

Over-the-counter medications, durable medical equipment, and other non-prescription medical supplies are not part of the SFS discount program.

What is the Ravenswood Assistance for Pharmaceuticals (RAP) program?

The Ravenswood Assistance for Pharmaceuticals (RAP) program is a Pharmacy Assistance Program that obtains free medications from pharmaceutical companies. **Patients eligible for Sliding Fee Scale discounts who are prescribed any chronic care medications may apply to the RAP program.**

When would I apply to the RAP program?

Patients eligible for the SFS discount program who are prescribed high-cost medications with an acquisition cost (AC) of over \$100 per prescription are asked to apply to the RAP program within the first 30 days of receiving these high-cost medications. Patients who apply to RAP and do not qualify for free medications through RAP will be charged for their high-cost medications at a discounted rate according to the "Rx \$100+" Sliding Fee Scale (see front).
